# **General Terms of Use**

#### 1 Introduction

SmartGames.tv is a service edited by NGINE NETWORKS SARL whose registered office is 30 rue Proudhon, 93210 La Plaine Saint Denis, France, hereinafter the "Company". As a user of SmartGames.tv, you agree to abide by these General Terms of Use, hereinafter the "GTU". If you do not agree to this GTU, you must not use SmartGames.tv.

# 2 Using of SmartGames.tv

#### 2.1 Fees to access Smartgames.tv

Equipment (SmartTV, Set-Top-Boxes, computers, mobile phones, internet browser, etc.) used to access SmartGames.tv services are under your exclusive responsibility, as are the telecommunication costs incurred by their use.

#### 2.2 Usage Rules

When using SmartGames.tv, you agree to abide by the rules include the following:

- Comply with applicable laws and respect the rights of third parties, and these provisions.
- Respect the intellectual property rights relating to content supplied by SmartGames.tv and by other users.
- Never divert a SmartGames.tv feature from its originally intended usage.

In particular, do not load more than 1000 pages during the same hour.

#### 2.3 Breach to these rules

In case of failure by a user to one or more of these rules, the Company reserves the right to unilaterally block access to any or all services, either temporarily or permanently, without any compensation.

# 3 Data privacy

SmartGames.tv website and services respect your right to privacy and complies with the relevant Data Protection regulation in France and in the European Union.

SmartGames.tv does not store any personal information.

#### 3.1 Cookies

SmartGames.tv uses cookies when you visit the website, so you do not have to enter the same information every time you access the site. You can deactivate the use of cookies by changing the preferences in your web browser. In this case, some features of SmartGames.tv may not longer be available or may work partially.

# 3.2 Technical data collection

Some technical data can be collected, such as the version of your web browser (Opera, Webkit, Chrome, ...), your operating system (Linux, Tizen, Android, tvOS, etc.), the technical IDs of your equipment (mobile IMEI number, MAC address, etc..), and your IP address.

#### 4.1 SmartGames.tv services usage

You are prohibited from editing, copying, reproducing, uploading, posting, transmitting, commercially exploiting and / or distributing in any manner whatsoever the SmartGames.tv services, the SmartGames.tv website pages, and the SmartGames.tv applications, or part of its computer codes.

#### 4.2 User failure to fulfil its obligations
